- > BNZ may decide to its sole discretion, on any grounds it thinks fit and, without rendering BNZ or Xero liable in any way, to discontinue the provision of Data to Xero pursuant to this authority by written notice;
- > any revocation of this authority by me/us will not take effect until 48 hours after written notice of the revocation is received by BNZ from me/us;
- > BNZ may vary the terms and conditions under which it supplies information pursuant to this authority by written notice to me/us;
- > the liability (if any) of BNZ and Xero arising out of this authority is several and neither party is jointly liable for the actions, omissions, fraud, or negligence of each other; and
- > Xero and BNZ's liability for the breach of any warranty implied by the Consumer Guarantees Act 1993 (if information is supplied for the purposes of a business, the Consumer Guarantees Act will not apply) or any relevant legislation in supplying the information will be, to the extent permitted by law, limited to supplying the services again; or the payment of the cost of having the services supplied again, the choice to be at the option of BNZ or Xero as applicable.
